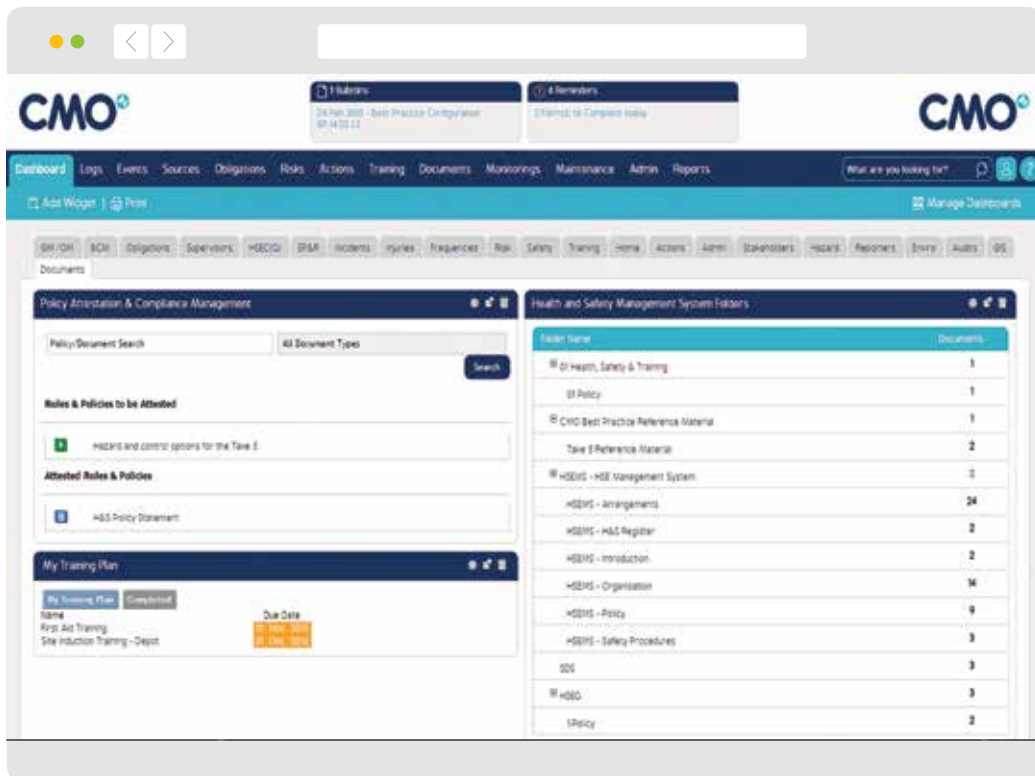
Compliance Management
